Introduction

The aging process is not the same for everyone. Internal and external factors will determine “how” and “when”. Some people just don’t look their age. In fact, two kind of aging processes occur at the epidermis level, and not necessarily at the same speed. The biological process is genetically programmed and will depend on our hormone production (decreasing with age). A premature aging process will depend on our life style and environment. Stress, smoking habits, drugs, unbalanced diet, heat, cold, pollution and overexposure to sunlight will accelerate a low, inevitable process affecting every skin component.



Cellular renovation process

“Keratinization” is the name of the process where skin gets renewed every 28 days -while we are young. Keratinization goes by creating a corneus layer that mediates with the environment and protects the skin from external factors. For the first fourteen days new cells are born and begin multiplying within the basal layer. As they move toward the surface they produce a keratin structure while absorbing lipids. They finally increase six times the original size. For the next 14 days, the cells get flat, liberate lipids and arrange themselves in rows. Once in the surface, they produce a corneus, flexible and compact layer that resembles a roof –cells are “tiles” and lipids are “cement”. This epidermal net keeps naturally exfoliating itself all the time (and we don’t even notice!). However, as time goes by, beginning at the age of 25, our epidermis will lose energy and “rhythm”. That sponatenous renovation will never be the same! Our skin begins to change and the corneus layer stops working as an effective barricade and renovation-machine. Keratinization process becomes longer and for someone of 40 years old, it takes more than twice the time to be completed.

What’s going on inside your skin?

Aging causes a series of events in every layer of your skin. Let’s see what happens with the corneus layer. As time goes by, the skin will not eliminate -and certainly will not restore cells the way it used to. This “slowed-down” cellular renovation produces keratinocytes and lipids of inferior quality that compromise the barricade function of the corneus layer. Cells build up in an irregular way and prevent the light from being appropriately reflected in all directions (that explains the haggard, bright less tone). Additionally, fissures and disorganization cause water to evaporate at undesirable speed (that uses up the water reservoir!). The hydrolipidic film that used to cover and plasticize our skin becomes poor (that makes our skin look dry, withered, and vulnerable to environmental factors that

erode and irritate the dermis).

At the dermis level, supporting fibers, collagen and elastin lose properties and recovery power. Fibroblasts and cells responsible for producing them slow down their activity (that makes our skin lose the mattress it relies on). Expression lines appear in the most stressed areas as a natural consequence of gestures. After a while they become wrinkles, because flaccidity will favor dramatic marks in our face. Here comes the time when our cheeks and lids become droopy, and the lower jaw becomes blurred. At the hypodermis level, connective tissue that surround fatty lobes is sclerosed, sweat glands begin to atrophy and fatty cells become scarce. For all of these reasons, our skin loses tone and flexibility, and doesn't serve a retaining wall anymore. As a result, fatty tissues surrender to gravity and begin to look like "drooped" skin.

What's going on outside?

What you see is the result of something that happened inside, right? Here is a list of typical visible changes. Ultraviolet rays, which have an accumulative effect on the skin, will alter the natural production speed of melanocytes. This causes "spots" to appear in the skin (actually those spots mean too much melanin). Our epidermis loses weight and capillary vessels get clearly visible, which leads to couperose, telangiectasias, etc. As we become older, that micro-relief net progressively disappears and some not very deep wrinkles appear. At the beginning they follow a single direction, later they begin to cross each other producing a deep grid. Our skin loses density and gets less resistant to traction. The hydrolipidic film –that has no longer the typical secretions from the fatty and sweat glands- is altered and water is dramatically lost. Expression lines are the first things we see –an early announcement of deep furrows sowing first around the eyes, nasogenian area, forehead and brows. The most dramatic wrinkles are those related to cutaneous and muscular relaxation. They blur the oval of the face and may lead to additional undesired effects, e.g. double chin, eye-bags, neck jowls, droopy bust, hand spots, etc.

Use the recommended 2000 mg (4 capsules) of Phyll "at one sitting". Do not administer this product to children.

Phyll will not interact with other drugs.
